You acknowledge and fully understand that by entering into the J-Rock Revolution Visual Kei Inspired Fashion Competition administered and coordinated through J+CONOCLAST, you have agreed to be bound by the following terms and conditions. Your entry should not be submitted if you are not in agreement with the following terms as your submission will constitute your acknowledgement of such agreement. 1. ELIGIBILITY: The "J-Rock Revolution Visual Kei Inspired Fashion Competition" ("Competition") is open only to permanent legal U.S. residents physically residing in United States (excluding its territories and possessions). Minors under the age of 18 years old must have their parent or guardian's permission to enter as described below. Void where prohibited by law. All applicable laws apply.

2. COMPETITION PERIOD AND ENTRY: The J-Rock Revolution Visual Kei Inspired Fashion Competition is being coordinated through J+CONOCLAST and provides competitors and contestants (each an "Entrant") with the opportunity to submit a Visual Kei Inspired creation ("Entry Design"). Entry Designs will be judged and eligible for the Prize described below subject to the terms and conditions herein at the The J-Rock Revolution Visual Kei Inspired Fashion Competition will take place on July 2nd, 2009 at the J-Rock Revolution Panel at Anime Expo in Los Angeles, California. To participate, Entrants must register for the Competition by completing all necessary forms as described herein and submit all artwork and or photographs in connection with registration. Any attempted form of entry other than as described herein is void. Entry into the Competition may only be made during the as described herein during the Competition registration deadlines set forth by J+conoclast.

To enter, Entrant must first carefully read, review and complete all of the required fields of the Official Competition Entry Form ("Entry Form") including Entrant's first name, last name, age, complete home address, telephone number and e-mail address. If Entrant is under the age of legal majority in his or her state of resident, the Entrant's parent or guardian must complete and submit the Entry Form and the Parental and/or Legal Guardian Consent Form. 4. JUDGING AND NOTIFICATION: All Entry Designs will be screened and those that comply with these rules will be evaluated by J+CONOCLAST. The top Entry Designs will be selected for presentation at J-Rock Revolution's panel at Anime Expo on July 2, 2009. The top Entry Designs will be notified no later than June 30, 2009. The top Entry Designs selected must cannot be presented at the J-Rock Revolution panel unless the Entrant or a representative meets with J+CONOCLAST no later than noon July 2, 2009. The top Entry Designs will be judged by the J-Rock Revolution's panel speakers and special guests at Anime Expo on July 2, 2009. Any Winners of the Competition will be selected on or about July 2nd, 2009 from all eligible entries received by the judge(s), whose decisions are final and binding in all respects. Odds of winning depend on the number of eligible entries received and the quality of the designs, as determined by the judges. Winners must be present to win and any winners will be notified in person.
